Commercial Producers Indemnity

There are five sections to this coverage designed to provide the main area of cover to a production for the Production Company. Non-appearance of Key Crew and Artists engaged by the Production Company, Extra Expense, All Risks on Negative and Videotape including whilst in safekeeping and storage, All Risks on Equipment including continuing Hire Charges and Props, Set and Wardrobe.

Advertising Agents Contingency

There are four sections to this coverage designed to provide the main area of cover to a production for the Advertising Agency. Non-appearance of artists and extras engaged by the Advertising Agency, Death and Disgrace of all artists including celebrities, withdrawal from transmission from any cause and All Risks cover on the Product.

Adverse Weather

Cover to protect the production against the cost to re-shoot a particular day affected by adverse weather from Precipitation Only through to Sunshine cover, including high or low wind speeds anywhere in the World.

Professional Indemnity/Errors & Omissions

Cover to protect Production Companies against their contractual obligations in respect of copyright infringement or alleged copyright infringement and Advertising Agencies for their contractual obligations for the oral or visual content of commercials and the copyright or moral rights to materials supplied by them for their commercials.

Terrorism and War

To protect against additional costs following the cancellation, abandonment, interruption or postponement of a shoot affected by a terrorist act or act of war.

Office Combined

Cover to protect the contents of the office against loss or theft and additional expenditure to continue trading in the event of a total loss.

Employers Liability/Workers Compensation

Depending on the country of domicile of the employees, whether permanent or freelance, specific cover will need to be taken against death or injury following a negligent act by the Client.

Public Liability/General Liability

Cover protects the Client for the legal liability for injury to third parties and damage to third party property. Limits depending on the location country vary from € 2,000,000 to € 20,000,000.

Motor Insurance

If a vehicle is being used in front of camera for a commercial, it is a legal requirement for cover to be placed on that vehicle. Short period cover available from one day to fourteen days.

Personal Accident and Travel

To protect crew and artists whilst travelling overseas on recces or productions.
